Please follow the steps below *before* your immigrant visa interview at the U.S. Embassy Addis Ababa, Ethiopia:

## Step 1: Register your appointment online

You need to register your appointment online. Registering your appointment provides us with the information we need to return your passport to you after your interview. Registration is free. Click the “Register” button below to register or call +251 011 558 2424.

If you want to cancel or reschedule your appointment, you will be able to do so after you register your appointment.

## Step 2: Schedule a medical exam in Ethiopia

As soon as you receive your appointment date, you must schedule a medical exam in Ethiopia. Please schedule your medical exam at least three weeks before your appointment date as you will need to go to the Embassy for case prescreening the day after your medical exam, Monday-Thursday at 1:30 p.m. Diversity Visa applicants should arrive at 1:00 p.m. to pay the application fee prior to their case prescreening.

Click the “Medical Exam Instructions” button below for a list of designated doctor’s offices in Ethiopia. Please schedule and attend a medical exam with one of these doctors and then come to the Embassy for case prescreening the day after your medical exam, Monday-Thursday at 1:30 p.m. Diversity Visa applicants should arrive at 1:00 p.m. to pay the application fee prior to their case prescreening.

## Step 4: Attend your case prescreening appointment

Applicants will need to go to the U.S. Embassy for case prescreening the day after their medical exam, Monday-Thursday at 1:30 p.m. Diversity Visa applicants should arrive at 1:00 p.m. to pay the application fee prior to their case prescreening. Applicants who have their medical exam on Thursday or Friday should plan to come for case prescreening the following Monday or Tuesday.

Applicants will not be able to attend their scheduled interview if they have not gone to the Embassy for case prescreening prior to their scheduled interview. Failure to attend the prescreening appointment will delay the processing of your case.

### What to Expect on the Day of Your Prescreening Appointment

#### **ARRIVAL**

Timely Arrival is Required. Please arrive promptly at 1:30 p.m. for regular visa applicants and 1:00 p.m. for Diversity Visa (DV) applicants.

#### **SECURITY SCREENING**

After arriving you will be required to go through a security screening. No personal items are allowed into the Consular waiting area. You may bring only the documents necessary for your interview, including your passport, appointment packet, and other supporting documentation.

#### **INTAKE**

After security screening, you will be directed to the consular waiting area. You will then be directed to an intake window where you must present your medical exam completion form, passport, 2 photos and civil documents.

Once prescreening is completed, you will be provided a sealed envelope with all your documents that you should not open and bring back for your scheduled interview. If you are missing any required items, a checklist with the missing items needed for the interview will be attached to the sealed envelope.

You will be refused an interview on your scheduled interview date if you do not bring the missing items along with the sealed envelope.

# Medical Exam Instructions



All immigrant visa applicants, regardless of age, require a medical examination prior to the issuance of a visa. Only a physician accredited by the U.S. Embassy can perform this exam. **It is your responsibility to schedule a medical exam with one of the offices listed below at least three weeks before the interview** at the U.S. Embassy. Medical examination results from other physicians are not accepted.

**IMPORTANT NOTICE: Please be advised that starting December 1, 2024, all applicants are required to go to the Embassy for case prescreening the day after their medical exam, Monday-Thursday at 1:30 p.m. Diversity Visa applicants should arrive at 1:00 p.m. to pay the application fee prior to their case prescreening. Applicants who have their medical exam on Thursday or Friday should plan to come for case prescreening the following Monday or Tuesday.**

**Applicants will not be able to attend their scheduled interview if they have not gone to the Embassy for case prescreening prior to their scheduled interview. Failure to attend the prescreening appointment will delay the processing of your case.**

## Items to bring to your medical examination

The doctor will need the following items to complete the medical exam forms:

- Your visa interview appointment letter,
- Your passport,
- Six (6) recently taken passport-sized color photographs, and
- A copy of your immunization records.

# Medical Exam Instructions



You should allow **at least 21 days** to complete the medical examination process, from start to finish. Please also make sure that you do not book the appointment earlier than three (3) months before your scheduled immigrant visa interview with the embassy. Any medical examination fees are performed at applicant expense, including x-ray and blood tests. Fees must be paid directly to the examining physician or clinic.

## During the medical exam

---

The medical examination will include a medical history review, physical examination, and chest X-ray, gonorrhea test, and blood test (for applicants 15 years of age or older). The United States also requires tuberculosis (TB) testing for all applicants two years of age and older. Please be prepared to discuss your medical history, medications you are taking, and current treatments you are undergoing. More information on general medical requirements for U.S. immigrants is available on the [Centers for Disease Control and Prevention Website](#).

U.S. immigration law requires immigrant visa applicants to obtain certain vaccinations prior to the issuance of a visa. Current immigrant vaccination requirements are available on the [CDC website](#). You can also read Frequently Asked Questions about our medical examination requirements on [Travel.State.Gov](#).

## After the medical exam

---

**IMPORTANT NOTICE- Please be advised that starting December 1, 2024, all applicants are required to go to the Embassy for case prescreening the day after their medical exam, Monday-Thursday at 1:30 p.m. Diversity Visa applicants should arrive at 1:00 p.m. to pay the application fee prior to their case prescreening. Applicants who have their medical exam on Thursday or Friday should plan to come for case prescreening the following Monday or Tuesday.**

**Applicants will not be able to attend their scheduled interview if they have not gone to the Embassy for case prescreening prior to their scheduled interview. Failure to attend the prescreening appointment will delay the processing of your case.**

The physician uploads the medical result in the system (eMedical) or sends hard copies directly to the Embassy and the consular officer can see the results.

Any x-rays taken will be given to you. You **DO NOT** need to bring the x-rays to your visa interview unless you suffer from tuberculosis (TB). However, you **must** carry the x-rays with you when you travel to the United States for the first time.

The medical report must be less than six months old when you enter the United States as an immigrant.

## Pre-Interview Checklist



**Please use the list below to determine the items that the applicant must bring to the case prescreening and the immigrant visa interview:**

- A copy of your NVC interview letter (does not apply to Diversity Visa, fiancé(e), adoptive, or asylee/refugee applicants).
- Unexpired passport valid for six months beyond your intended date of entry to the United States and a photocopy of the biographic page (where your name and photo are located).
- Two (2) color photographs of each person applying for a visa (5 cm x 5 cm, or 2 inch x 2 inch). Please review our [online photo requirements](#).
- Confirmation page from the Form DS-260 Application for an Immigrant Visa you submitted online at [ceac.state.gov/iv](https://ceac.state.gov/iv).
- Your **original** birth certificate, English translation, and a photocopy.
- Medical examination results in a sealed envelope (*if the physician gives you these results*) or *accomplishing slip*.
- Original or certified copies of birth certificates for all children of the principal applicant (*even if he or she is not accompanying*).

**Applicants who fall into any category below should bring these additional documents to the case prescreening and the immigrant visa interview:**

*For family-based visa applications:*

- The appropriate [Form I-864 Affidavit of Support](#) for **each** financial sponsor along with a photocopy of the sponsor's IRS transcript or most recent U.S. federal income tax return, and any relevant W-2s.

**Please note:** To prevent unnecessary delays, additional evidence of the petitioner's finances is often useful: petitioner tax records for the last three years, job letters specifying salary and length of employment, W-2 forms, and/or payment stubs. Please bring recent financial information to your interview to show that the Petitioner meets the minimum Poverty Income Guidelines.

- Proof of your U.S. petitioner's status and [domicile](#) in the United States (photocopy of a U.S. passport, naturalization certificate, or lawful permanent resident card).
- Evidence of the relationship between the petitioner and visa applicant. Evidence may include historical photographs, communications such as letters/e-mails or phone records before and after marriage, social media (Facebook, Viber, SMS, etc.), bank records, money receipt orders, joint property, and joint management of finance, etc. The evidence must be authentic. If you do not have sufficient evidence of a family relationship, we may not be able to process your visa.
- Evidence of age:* For certain visa classes that are age dependent (IR2, CR2, F2A, FX2) you must bring sufficient, legitimate evidence of your age. Such evidence might include school records, medical records, church records, or other evidence that will demonstrate age.
- If you are married:* Your **original** marriage certificate, English translation, and a photocopy.
- If you were previously married:* Your **original** divorce or spouse's death certificate, English translation, and a photocopy.

## Pre-Interview Checklist



- If you are older than 16 years of age:* The **original** police certificate from your country of current residence and countries of previous residence. If these three items are **all** true, you must bring a more recent police certificate to the interview:
1. You are older than 16 years of age;
  2. You obtained a police certificate and submitted it to NVC more than two years ago; and
  3. You still live in the country that issued the police certificate.

- For employment-based visa applications:* A letter from your U.S. employer dated less than one month ago.

**Please note:** If you are immigrating to the United States through employment (such as EB1), the I-864 Affidavit of Support (AOS) is generally not required. The AOS is required only if your relative filed the IV petition on your behalf or has at least a 5% ownership interest in the business that filed the petition. The letter from your U.S. employer should also confirm that the employment officer is still valid and available as of the time of the interview. *This statement must be on employer stationary and be notarized.*

- If you have ever been convicted of a crime:* Court and criminal records, English translation, and a photocopy.

- If you have served in any country's military:* Military records, English translation, and a photocopy.

- If you are adopted:* Adoption papers or custody documents, English translation, and a photocopy.

- If you are the petitioner's stepchild:* The **original** marriage certificate of the petitioner and your biological parent, English translation, and a photocopy along with divorce records for any previous marriages of either parent.

# Interview Guidelines



These instructions will help you prepare for your case prescreening and Immigrant or Diversity Visa appointment at the U.S. Embassy in Addis Ababa. Please read all instructions completely. U.S. law (the U.S. Immigration and Nationality Act or INA) requires every applicant demonstrate that they qualify for a U.S. visa. This means that the petition's beneficiary must show a valid relationship, that you must prove your correct age and identity, and that all requirements are met – such as education or work experience. A consular officer can make a decision on a visa application only after reviewing the formal application and interviewing the applicant. **There is no guarantee that you will receive a visa.** Do not make any travel arrangements, quit your job, or sell property until you receive a valid U.S. visa.

## Sending documents to the U.S. Embassy Ethiopia

If you need to send us any documents, please DO NOT mail them to us directly. Instead, visit [ais.usvisa-info.com](https://ais.usvisa-info.com) and ask for information on courier services. Please do not send any original documents to us; only send photocopies via courier or mail. You may bring original documents (plus a photocopy for the embassy's files) to your visa interview.

## Rescheduling or cancelling your interview

If you are unable to attend your appointment, please go to [ais.usvisa-info.com](https://ais.usvisa-info.com) to select a new appointment date. **There may be a significant wait before the next available appointment**, so please attempt to attend the date already assigned. For some family-based and employment preference visa categories, a visa became available within the month you have been scheduled by NVC. DV applicants should be aware that visas are numerically limited and must be issued by September 30 of the program year. **There is no guarantee that a visa will still be available on the date of your rescheduled interview.** Please carefully consult the [Visa Bulletin](#) before you request to reschedule your interview. Please reschedule your appointment through the "Missed My Appointment" option in your online account at [ais.usvisa-info.com](https://ais.usvisa-info.com) or by calling +251 011 558 2424. Failure to appear for your interview within one year may result in the cancellation of your petition.

**Please note:** You need to register your original NVC/KCC appointment online before you can reschedule it. Rescheduling is only possible on a date *after* your assigned appointment.

## Security screening procedures

All visitors to the U.S. Embassy Addis Ababa, Ethiopia, must follow certain security procedures. Any visitor who declines to be screened by U.S. Embassy security personnel will be unable to enter the Embassy. To avoid delaying your entry and that of those in line behind you, please bring only what is required for your interview. If you leave items in your car, be sure to put them in the trunk and lock your car; do not leave any personal items in view in the passenger compartment. **Please arrive at least 30 minutes before your appointment to clear security. Applicants will not be allowed to enter after 10: a.m. on the day of their interview, regardless of the circumstances.**

## Items Prohibited in the Consular Section

In accordance with security regulations, **the following items are prohibited inside the Consular Section:**

- Weapons or explosive materials of any kind
- Sharp objects, such as scissors, pen knives, or nail files
- Laptops or larger electronic devices
- Personal electronic devices, including mobile phones, tablets, portable music players, smart watches, and other smaller electronic devices.
- Cameras or video recorders

# Interview Guidelines



- Software and media, including remote controls, flash drives, CDs, DVDs, or Bluetooth-enabled devices.
- Any bags, backpacks, briefcases, suitcases, leather bags, cloth bags, or shoulder bags.
- Food and beverage items, including bottled water (\*baby formula/food may be excepted)
- Cigarettes (including electronic cigarettes), cigars, match boxes, and lighters
- Sealed packages

**This list is not exhaustive.** Other items may be prohibited at the discretion of the security staff.

Medical devices and medication are allowed in the waiting room.

You will not be allowed to enter the building with prohibited items. Please make other arrangements to store prohibited items before entering the consular section. Failure to follow these guidelines may result in significant delays or cancellation of your appointment.

## Accompanying persons

Attorneys are **not** permitted to accompany clients into the waiting room or to their interview.

Access to the Consular Section waiting area is limited to the following:

- Applicants
- Parents (1) or legal guardians (1) of applicants under 18 years old
- Aides of disabled applicants
- Translators for applicants who do not speak English, Amharic, or other common Ethiopian languages

## What to Expect on the Day of Your Prescreening Appointment and Visa Interview at the US Embassy Addis Ababa

Visa appointment holders must have an appointment confirmation page and may not be admitted more than 30 minutes before their appointment. Applicants arriving for their case prescreening must present their medical exam completion slip in order to be admitted.

### **ARRIVAL**

Timely Arrival is Required. Please arrive no more than 30 minutes before or after your appointment. You will not be allowed to enter after 10:00 a.m. on the day of your interview, regardless of the circumstances.

### **SECURITY SCREENING**

After arriving you will be required to go through a security screening. No personal items are allowed into the Consular waiting area. You may bring only the documents necessary for your interview, including your passport, appointment packet, and other supporting documentation.

### **INTAKE**

After security screening, you will be directed to the consular waiting area. Will be directed to an intake window, where you must present your appointment letter, passport, 2 photos and civil documents.

### **INTERVIEW**

When instructed, proceed to the window for your interview. The officer may ask for proof of relationship, financial documents and other relevant documentation.



# Interview Guidelines



## DECISION:

At the end of the interview, the officer will decide your visa eligibility. Generally, the officer will decide in one of three ways:

1. The applicant is eligible for the visa.
2. The case must undergo further administrative processing prior to a final decision
3. The applicant is refused the visa.

The officer will inform you of any next steps. After this, your appointment is complete, and you should depart the Embassy.

## Immigrant visa fees

---

If you have not paid all required fees to either the National Visa Center or via the appointment website, please be prepared to pay these fees on the day of your interview.

**Please note:** The fee for an Immigrant Visa (IV) is USD 325.00 per person or the equivalent in local currency. IV applicants must pay this fee on the day of your prescreening if the petitioner (your sponsor) did not pay this fee in advance. The fee for a Diversity Visa (DV) is USD 330.00 per person or the equivalent in local currency. DV applicants **must** pay this fee at the U.S. Embassy at 1:00 pm on the day of your case prescreening.

*If you are found ineligible to receive a visa, the application fee cannot be refunded.* You can find a complete list of fees on our [Fees for Visa Services webpage](#).

## Do not make travel plans outside of Ethiopia

---

If your visa is approved, we will keep your passport at the embassy while we prepare your immigration packet and print a visa for your passport. We will return your passport to you later via courier services only. If you have to travel within Ethiopia while your passport is still with us, please make sure you have a valid picture ID other than your passport.



## After Your Visa Interview

### If more information is needed

Sometimes a consular officer is unable to make a decision on a visa application because he/she needs to review additional documents, or the case requires further administrative processing. *When additional documents are requested*, the consular officer will give you a refusal letter that asks you to submit additional documents. The letter will include instructions on how to send those documents to the embassy or how to upload in the system. *Administrative processing* takes additional time after the interview. Most administrative processing is resolved within 60 days. However, the timing varies based on the circumstances of each case. Before inquiring about the status of administrative processing, please wait **at least 60 days** after your interview.

### What happens after visa approval?

**Passport, Visa, and Sealed Immigrant Packet** – We will place your immigrant visa on a page in your passport. Please review your visa to make sure there are no spelling errors. Please be sure that your name appears on the visa exactly as it appears in your passport. If you notice any error, please bring it to consular staff's attention by returning to the embassy at 02:00 p.m. on any Wednesday. We will also give you a sealed envelope containing documents that you must give to U.S. immigration authorities when you arrive in the United States for the first time. If you receive X-rays during your medical examination, carry those with you and give them to the U.S. immigration authorities.

***Do not open this envelope. You must carry it with you; do not put it in your checked luggage. If you open the envelope you may be denied entry to the United States.***

***For Modernized Immigrant Visa cases, your documents are uploaded in the system so we will give you your passport with the visa attached (no sealed envelope).***

If your visa category requires you to be single (e.g. IR2, F2B, F2A child) you must remain unmarried until you travel to the United States and obtain Lawful Permanent Resident (LPR) status. If you change your intended U.S. address after obtaining your visa, please notify the immigration officer at the port of entry.

**USCIS Immigrant Fee** – All individuals who are issued immigrant visas overseas must **pay an [Immigrant Fee](#)** to U.S. Citizenship and Immigration Services (USCIS) **prior to traveling** to the United States. This fee is for processing your residency status and printing your Permanent Resident Card. The only people exempt from paying this fee are: children entering the United States under the Hague Process, returning residents, and people traveling on a K visa.

**When You Should Travel** – You must enter the United States *before* the expiration date on your visa, which is usually six months from the date of printing. If the visa category on your passport is F11, F21, FX1, F24, F31, F41, E11, E21, SE1 or DV1 the principal applicant must enter **before or at the same time** as other family members with visas. **The period of your immigrant visa validity is printed on the visa.** It may be less than six months if other documents in your case, such as your medical exam, expire within that time. Your visa is single-entry and not renewable except in an exceptional circumstance.

**Getting a Green Card** – Your Form I-551 Permanent Resident Card, also known as a green card, will be automatically mailed to the address in the United States that you write in your visa application form. This is a very important document that proves you have permission to reside in the United States. *If you plan to travel outside the U.S. before your green card arrives:* Please consult [USCIS's](#) and [CBP's](#) websites for rules about what documents you need to re-enter the country. We also recommend you check with the airline to ensure you are in compliance with their rules. *Once your card is issued, you should not stay outside of the United States for more than one year. If you do, you will lose your status as a Lawful Permanent Resident.*

## After Your Visa Interview



**Children’s Issues** – In the United States, children are required to have certain vaccinations before they can enroll in school. We recommend that you bring your child’s complete vaccination records with you to the United States. If your child is adopted, you have full custody as a result of a divorce, or you share custody with another parent, you should bring a copy of all applicable adoption or custodial papers from the authoritative court in your home country. You will need these papers (translated into English) for issues such as school enrollment, medical care, and eventual citizenship.

## Diversity Visa Applicants – Additional Information



If you are interviewing for a Diversity Visa (DV), all of the above instructions apply to you. Please schedule and attend a medical examination prior to your visa interview; gather the required documents; complete your prescreening; and enroll in the required courier service.

Below are additional instructions that apply **only** to DV applicants. For instructions in Amharic, please follow [this link](#).

### Bring to your interview

---

In addition to the documents listed on the Pre-Interview Checklist in this package, DV applicants should also bring the following items to your case prescreening and visa interview:

- Appointment information printed from the “Entrant Status Check” on the [E-DV website](#).
- Documents showing that you have either a qualifying high school education **OR** have two (2) years of qualifying work experience in the last five (5) years immediately prior to application (for the principal applicant only; more information is available on our [Diversity Visa Process webpage](#)).
- \$330 cash payment for the Diversity Visa Application Fee for each visa applicant. *This fee is non-refundable and must be paid prior to your case prescreening.*
- Educational qualifications: You must possess **one** of the following as evidence of your educational qualifications. You must submit official copies of school transcripts along with your educational certificates. These requirements are determined by U.S. immigration law, and are not determined by the embassy:
  - Proof of graduation from 12th grade (including an Ethiopian Leaving Certificate Examination, a University Entrance Exam, or a Higher Education Qualification Exam).
  - Proof of graduation from a four-year university.
  - *Note: TVET 10+3 or 10+4 certificates are no longer acceptable.*

If you cannot meet the educational requirements, you may submit evidence of qualifying work experience. Qualified work experience is defined as at least two years of full-time employment during the past five years in an occupation that requires at least two years of college training or experience. Please be advised that it is very difficult to fulfill the educational requirements based on work experience. Qualifying occupations are defined as those with Specific Vocational Preparation (SVP) rating of 7 or above and are listed as job zone 4 or 5 on the U.S. Department of Labor’s Occupational Skills List found at [onetonline.org](http://onetonline.org). We strongly suggest you research your work experience on this website before proceeding with your DV application if you wish to qualify based on work experience.

**Somali citizens:** The U.S. Embassy in Addis Ababa cannot verify educational or work experiences that occurred in Somalia. Without such verification, please know that it may not be possible to process your case to completion.

**If you submit any fraudulent documents with your application, you will be ineligible to receive a visa.**

Documents presented are subject to independent verification by trained professionals. Do not take the risk of presenting a false document. Marrying a person in order to confer an immigration benefit through the Diversity Visa program WILL result in a permanent ineligibility for both you and your spouse.

## Diversity Visa Applicants – Additional Information



### Review your DV Lottery entry

---

Prior to your visa interview, we recommend that you review the data on your initial E-DV entry. On your initial E-DV application, you must have correctly entered your marital status. If you are legally married you must have listed your spouse, even if you are currently separated from him/her (unless your spouse is a U.S. citizen or Lawful Permanent Resident). This includes children who are your spouse's from a previous marriage, and children who have been formally adopted. The only exceptions are:

- If your child is already a U.S. citizen or a U.S. Legal Permanent Resident, **or**
- If you were legally divorced before the DV entry.

Additionally, you must have listed ALL of your living children who are unmarried and under 21 years old. This includes your natural children, your spouse's children, or children you have formally adopted in accordance with the laws of your country.
